



RULES OF THE VIDEO CONTEST "2019 Best-Of"

ARTICLE 1- ORGANIZATION AND DATES OF THE COMPETITION

Kortel Design organizes a video contest, free of charge.

The competition runs from March 20 to April 12, 2020.

ARTICLE 2- THEME

- "2019 Best-Of"

This theme can be approached from different angles, but should allow the jury to immerse themselves in the atmosphere of your best moments of paragliding that took place in 2019.

ARTICLE 3 - CONDITIONS OF PARTICIPATION

This contest is free and open to all pilots.

Participants in the contest must be the owner of the rights related to the image and have the authorization of the identifiable persons on the scenes of the film.

Only one entry per person is accepted.

No image will be used by the organizers outside the contest. The distribution of images and results will be done via the organizer's website and its social networks.

The images must have been taken during the year 2019.

The deadline for submitting videos is midnight on 12 April 2020. Any entries arriving after this deadline will not be accepted.

The video must be sent in digital format (Via wetransfer, dropbox, or other) " MP4 " to: info@korteldesign.com

The duration of the photo should not exceed 2 minutes.

The name of the video file must be in the form "2019bestof-nom-firstname.mp4".

The subject of the email will be in the form: "2019bestof- photo-name-first name".

The body of the email will include:

- A comment of a few lines
- The first and last name of the participant
- The participant's postal address and telephone number
- Participant's email

Videos that do not meet these criteria will be eliminated.

ARTICLE 4: SELECTION CRITERIA

The videos will be evaluated on their technical and artistic value by the jury, as well as on their originality.
